Development contracts:

100% funded R&D services procurement contracts
UK implementation of EU Pre-Commercial Procurement.

Contract with a single organisation:

Who may choose to sub contract parts of the work

IP ownership rest with supplier organisation:

Certain usage rights with the public sector – suppliers are encouraged to exploit the IP

Open to organisations not currently engaged in the sector.

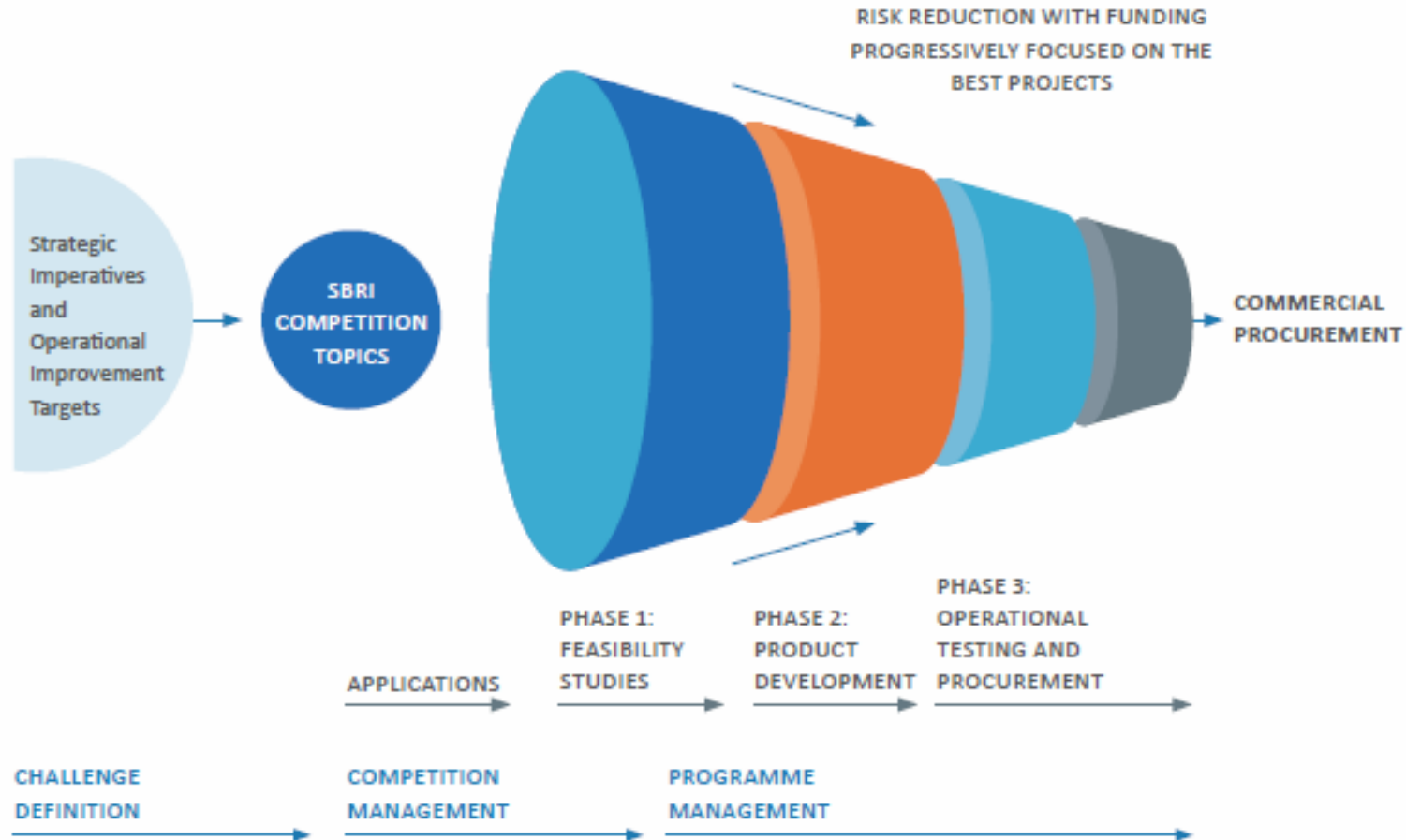
Research organisations may also apply, however all organisations must demonstrate a route to market

Application assessment

All applications are assessed against the assessment criteria

What do they look for?

- **Clear and concise** answers
- **The right amount of information**
 - not too much detail
 - no assumptions
- **Quantification and justification**
- A proposal that presents a **viable opportunity for growth, a level of innovation that necessitates public sector investment** and has the right **team and approach** to be successful

Keep your assessors engaged and interested in your proposal. You want them to be fascinated and excited by your idea!
